

Rental Agreement

1. Your Spa has been set to a temperature of approximately 37 C.
2. When using the spa, remove lid and store carefully. Enter the water with care making sure it is not too hot (test first). NO JUMPING.
3. When not using the spa always replace the lid to retain the heat
4. The spa will maintain the set temperature by itself – don't worry if the spa continues to run.
5. Please do not smoke or drink alcoholic beverages when using the spa.
6. Please do not take any glass objects to the spa.
7. Please do not use any electrical items (including mobile phone) within five feet of the spa.
8. Children must be over 10 years of age and accompanied by an adult at all times when in or around the spa.
9. At 37.5C or above you should not spend more than 15 minutes in the spa.
10. If you are pregnant or have a medical condition please check with your doctor before using the spa.
11. Please lock the cover when the spa is not in use.
12. It is essential that everyone using the spa showers before use and no foreign bodies (such as grass) are introduced to the water. Your spa will perform better if keep clean and therefore be more enjoyable to use.
13. Your spa is designed for 4 people. Overloading the spa can be cause damage for which you will be liable.
14. We mix chemicals to the water – this is to keep your spa water clean and healthy. You will also be shown how to maintain the water – you will be responsible for testing the water and adding the necessary chemicals.
15. Hottubs2hire Ltd will not be responsible for any water damage that occurs from spas set up indoors.

Any damage incurred due to misuse or not following the above recommendations must be paid in full. Undersigned hirer understands the above information and acknowledges that the use of the spa is at the hirers risk.

Undersigned hirer agrees to release our company from any liabilities incurred with the use of the spa.

9. No property in or title to the goods shall pass from the company to the customer unless and until the customer has made full and complete payment to the company.
10. The company does not accept responsibility for damage to any equipment in which our products are used for the purpose other than those for which it was designed.
